IMI – Collaboration EU Commission and the ER-WCPT

The Region has been invited by the EU Commission to collaborate in the development of the Internal Market Information (IMI) pilot project. The Executive Committee studied the invitation and agreed to answer the EU Commission expressing its willingness to participate in the project and also asking for further information. The EU Commission was pleased with the Region's offer and invited us to a meeting that took place on 12 July 2006.

At that meeting, Mrs. Pamela BRUMTER (Head of Unit of the European Commission, Internal Market, Regulated Professions (Unit D3)) and Mr. Nicholas Leapman (Deputy Head of Unit, Administrative Cooperation and Member States Networks), met the General Secretary and explained to him the aim of the project and the task to be developed by the Region.

The IMI project is a tool that seeks to facilitate the implementation of EU Legislation in the 25 Member States. This tool is necessary due to the problems of implementation of the legislation such as: different languages, no clearly identified partners, different administrative cultures and structures, lack of agreed procedures and 300 bilateral relationships to manage among others. For this reason, an administrative support is needed. To solve this problem the EU Commission started this project one year ago with the cooperation of the Member States since this tool, at least at the beginning, will only be used by the Authorities. The result was a preliminary tool to facilitate the communication among authorities of the Member States, avoiding the referred to problems, but which needs to be reviewed.

One directive was chosen as the first to be implemented through this tool, since the aim of this project is to implement directives in general. That directive was the Recognition of Professional Qualifications. After this, the Service directive will follow.

The Member Organisations and Working groups of ER-WCPT were asked to review the tool with its questions and send their comments to the secretariat before the 10 October 2006, since on 13 October 2006 was scheduled a meeting with the EU Commission to present a first revision.

On 13 October 2006, the EU Matters WG

and the Common Platform Task Force held a meeting with the Commission in Brussels where the tool was explained and the Region presented its comments. The Commission appreciated the comments and invited to present them in a meeting on 25 October 2006 with the other three professions invited by the EU Commission to review the tool (Accounts, Doctors and Pharmacists).

Physio delight as self-referral gets Government go-ahead – CSP, the U.K.

The Chartered Society of Physiotherapy (CSP) has welcomed government plans to pilot new schemes that will change the way patients access healthcare services.

Health Secretary Patricia Hewitt has announced the rollout and evaluation of pilot self-referral schemes across England. The schemes will allow patients to gain treatment and advice from physiotherapists and other allied health professionals without having to see their GP first.

Ms Hewitt said:

'We look forward to seeing the results of the self-referral pilots. It is clear that physiotherapists have already made good headway in delivering high quality projects in this area.

'Patients want to see the right specialist at a time of their choosing. For some this will mean going direct to a physiotherapist rather than more visits to their GP. These pilots will allow us to assess and potentially take forward greater direct access for patients.'

Welcoming the announcement, CSP Chief Executive Phil Gray said:

'This announcement offers a real opportunity for revolutionary change in how people access NHS treatment and will put English patients on a par with their counterparts elsewhere in the UK.

'Physiotherapists have been at the heart of developing self-referral schemes for some time. Evidence from pioneering programmes shows this practice offers up real solutions to some of this Government's toughest health challenges for England.

'Waiting times are slashed, demands on GPs are reduced, NHS money is saved – especially where musculoskeletal and long-term conditions are concerned – and patient outcomes are improved.

'Rapid physiotherapy access through selfreferral can also help the Government deliver on two major policy areas it has been pushing recently: helping people off incapacity benefit and the White Paper on care outside hospitals. We are looking forward to working with the Government to make self-referral a realistic prospect for all patients.'

Public consultation on EU framework for health services – Health Service Directive:

After the exclusion from the Services Directive of public and private healthcare, the European Commission decided to set up a specific EU health services framework to guarantee cross-border access to healthcare. As a first step, the Commission has launched a public consultation till the 31 January 2007, based on a Communication of the European Health and Consumer Protection Commissioner, Markos Kyprianou, providing ideas for an EU framework for safe, high-quality and efficient healthcare services. WHO and Obesity

EU Report - The "Connected Health: Quality and Safety for European Citizens"

The EU Report; "Connected Health: Quality and Safety for European Citizens" is now available online.

Developed with input from both the i2010 subgroup on eHealth (formerly known as the eHealth Working Group) and the eHealth stakeholders' group, this paper contributes to enhancing the continuum of care and ensuring that the flow of information between primary care (local health centres, general practitioners' offices), secondary care (hospital), and tertiary care (specialised consultative care) is promoted, on behalf of better patient care, safety and quality of life as well as better or new citizen-oriented services.

A systemic approach, that establishes a collaborative network among all health professionals and organisations, will be extremely beneficial for achieving the proposed goals. Health technologies should also be used to reinforce the information tools available to citizens,

helping them for example to inform themselves better about health issues. particularly preventative health measures. This paper outlines priority issues which must be pursued vigorously in order to reach all of these health systems goals improve patient safety, encourage wellinformed citizens and patients on health matters, and create high-quality health systems and services - and, at the same time, face international competition in the eHealth sector. It focuses on the overriding theme of comprehensive eHealth interoperability: eHealth solutions must be interoperable to facilitate and foster the collaboration of health professionals and health care organisations, and the various stakeholders must cooperate and involve themselves to resolve legal, organisational and policy barriers.
