## Summary of the Executive Committee Meeting in Dublin, Ireland, on 26-29 June 2008

After the 6th General Meeting of the European Region, which took place in May 2008 in Athens, Greece, the last Executive Committee Meeting of the European Region focused primarily on the feedback from the meeting on future activities for the period 2008 – 2010, and appointment of the members to the three working groups for this period.

The meeting also focused on the revision of the situation of the next events such as the 2nd Education Congress on Physiotherapy Education, to be held on 25 – 26 September 2008, in Stockholm, Sweden.

**Further work for the period 2008-2010** of the three working groups as recommended by the 2008 GM was reviewed by the committee and agreed as follows:

#### **Education Matters Working Group**

1. Follow up the implementation of the European Physiotherapy Benchmark Statement. To renew the EPBS with emphasis on physiotherapy specific knowledge, skills and competence as well as on the independence of the profession and its knowledge development

**2.** Updating of the Policy Statement on Physiotherapy Education since Education is evolving quickly due to the Bologna Process

**3.** Continuation of the Project on Specialisation

**4.** Address education issues for Member Organisations involved in the Enlargement process and cooperate with the EU Matters Working Group in Accession facilitating;

Monitoring and reacting to issues as they arise from enlargement

**5.** Identify information to be included on the website under the button of education relating to basic education, post basic education, and research

6. Gather information on quality assurance measures in Physiotherapy education and monitor the involvement of the Member Organisations in quality assurance activities

7. Follow up the activities on Continuous Professional Development within the Member Organisations, and continue to monitor developments in re-registration, recertification in collaboration with the Professional Issues Working Group

**8.** Monitor the developments in reregistration, re-certification in all the ER-WCPT countries, in collaboration with the Professional Issues WG

**9.** Continue facilitating closer links and cooperation with ENPHE.

**10.** Monitor and promote the use of Evidence Based Practice in Physiotherapy education at all levels (Life Long Learning)

**11.** Contribute to the completion of the 2nd European Congress on Physiotherapy Education

**12.** Prepare the 3rd European Congress on Physiotherapy Education to take place in 2012.

**13.** To complete the Pain in the back project and make recommendations for its implementation.

**14.** Maintain Glossary of key terms of the ER-WCPT to reflect all the documents produced by the Region

**15.** Identify issues related to research in Physiotherapy that might be addressed by the ER-WCPT

**16.** To investigate the relationships between MO's, the education providers, and their practice providers/partners

### French Presidency of the EU – Health Priorities

The French Presidency of the EU started on 1 July for a period of six months till 31 December 2008.

The Presidency wishes to place greater emphasis on three major themes:

- Alzheimer's disease: the Presidency will promote better care for sufferers and their

families, based on three strands of action namely, health, solidarity and research. This will entail fostering the exchange and sharing of national experience and, where applicable, cooperation on a subject that affects all Member States because of their ageing populations. A major European conference will be dedicated to this on 30-31

October in Paris;

- strengthening food security and safety in Europe: in light of the experience gained in preparing for a global influenza pandemic, and in accordance with the principle of subsidiarity, we must look into ways of improving coordination of the management of large-scale safety risks within the European Union. This topic will be specifically addressed at the informal meeting of EU Health Ministers scheduled for 8-9 September at Angers;

- EU health strategy serving the needs of patients: the French Presidency will further work on the proposal expected from the Commission.

# World Health Day 2008: "protecting health from climate change"

Traditionally, the climate change debate has been centred on issues such as the environmental and economic consequences of global warming; however, an aspect of the problem which should be at the core of the public agenda is the impact of climate change on human health. Many countries in Europe have already experienced significant climate change related events, leading to tens of thousands of deaths, and estimates predict more deaths from, for example, extreme weather.

The WHO Regional Office for Europe is engaged in developing partnerships to strengthen the support for its Member States in responding to the new threats to health posed by climate change. As more than half of these countries are also EU Member States the European Commission is a key partner. This is evident in a number of cofunded projects: EuroHEAT carried out an assessment of the health impact of heatwaves and promoted development of earlywarning tools and action plans; other projects include the European Flood Alert System, PHEWE, cCASHh, Eden, and MircoDYS.

This World Health Day, dedicated to "protecting health from climate change", provides an opportunity for all to place health at the centre of local, national and international dialogues, and to raise awareness of current and potential climaterelated threats to health.

Recognizing the importance of sharing the WHO agenda with the EU and EU-related stakeholders, WHO/Europe has chosen Brussels as one of the two European spots for this year's campaign on the World Health Day.
