EU's Directive on Working Time

The Commission launched, on 5 January 2004, an open consultation to determine how to amend the EU's Directive on Working Time (93/104/EC), which aims to protect the health and safety of workers by limiting their hours of work to 48 hours per week (including overtime), defining the rest periods at 11 consecutive hours a day and one day per week, and establishing a statutory right to four weeks of paid leave per year. The deadline for comments was 31 March 2004

The Injury Prevention Programme of the European Commission is based on two activities. First, the collection of data on injuries and accidents in the Member States, and secondly on epidemiological projects which are based on the collection of the above data and/or the collection of additional information.

Under the New Public Health Programme (2003-2008) the Injury Prevention activities will continue within the "Health Information Strand" and within the "Health Determinants Strand".

Commission proposal for a Directive on Services

On 13 January 2004, the European Commission presented its proposal for a Directive on Services in the Internal Market. This proposal aims to facilitate the administrative requirements in order to provide services in another Member State by removing legal barriers to the freedom of establishment and the free movement of services. lt recoanises the importance of professional orders and professional associations the in regulation of services. Besides establishing a list of forbidden requirements to access a service, the

Directive will oblige Member States to assess the adequacy of certain requirements – such as quantitative or territorial restrictions, particular legal forms for service providers or bans of having more than one establishment on the same national territory – with the provisions of the directive.

The Commission envisages that the proposal should be adopted in 2005 and be put into force by 2010.

Directive on Mutual Recognition of Professional Qualifications

The European Parliament adopted the proposed Directive on Mutual Recognition of Professional Qualifications COM(2002) 119 - C5-0113/2002 - 2002/0061(COD)) at first reading, on 11 February 2004, in Strasbourg. The text as adopted by the European parliament can be found at

Over 350 amendments had been proposed and over 100 amendments were adopted.

Many amendments have been made that make the proposed Directive clearer and more transparent. In many cases amendments have been made to articles were the European Region of WCPT had commented on and had concerns about.

The main amendments that have implications for physiotherapists are the following:

It was adopted to have ONE Directive instead of two directives, one sectoral and one general Directive.

Two committees for the recognition of professional qualifications must be set up and an appropriate way of involving professions' representatives the ensured for purpose. this One committee comprise the should groups professional at present regulated sectorally, and the second the other professional groups.

An individual professional card should be introduced. This card shall contain information on the professional's training, his professional experience, and any professional sanctions imposed on him".

It was adopted to delete the proposal from the Commission on 16 weeks



provision of professional activity in a host Member State.

There was adoption of a new paragraph on Recognition of professional experience as determining factor in advancing the university level of those with such experience to the level immediately above, in the classification laid down in Article 11 (that relates to levels of qualifications)".

The proposal of Common Platforms of European professional organisations was adopted.

There was an adoption of language skills necessary as the migrant shall ensure that he/she acquires the language knowledge necessary for performing his/her professional activity before undertaking such activity in the host Member State.

The text as amended by the Parliament will be debated by the Council of Ministers, which is expected to adopt a Common Position at the Competitiveness Council, to take place on 17 May 2004.

Summary of the Executive Committee Meeting in Estoril, Portugal, on 13-15 February 2004

Due to the General Meeting of the European Region, which will take place in May 2004 in Limassol, Cyprus, the last Executive Committee Meeting of the European Region focused primarily on the finalization of all documents, which will be discussed and eventually approved at the General Meeting. All these documents from the 3 Working Groups, i.e. Education Matters, Professional Issues and EU Matters, have been submitted for input and agreement by the Executive Committee. Each Working Group will also present their own report at the General Meeting regarding the work developed during the period 2002-2004 and a set of recommendations for 2004-2006.

Tackling health determinants through health promotion is emphasized as one of the major objectives under the EU Programme of Community Actions in the field of Public Health 2003-2008. The Executive Committee has therefore decided that a Discussion Session entitled "Network on Prevention and Promotion of Healthy Lifestyles" will take place at the General Meeting 2004. This discussion will assess the level of interest of the Member Organisations, and their willingness to create a European Region Network on Prevention and Healthy lifestyle. In the Discussion Session, Member Organisations will be called upon to provide their comments and feedback to the following questions:

- Should the European Region of WCPT create a network for MO's who are interested in sharing projects on health promotion and prevention?
- Would MO's be willing to share current (2004) projects (and contact names) on health promotion and promotion of healthy lifestyles?
- In the future should the General Meeting discuss and agree themes for promotion of healthy lifestyles that reflect European Health Policy priorities?
 e.g. Ergonomics in offices/ factories, Children and exercise

The aims of this Discussion Session is to achieve a set of conclusions, that will be presented as the Final Recommendations for Adoption at the General Meeting 2004.



A document entitled "The Framework for Clinical Guideline Development in Physiotherapy" will be presented and submitted for approval at the General Meeting. This framework for clinical guideline development, was written to create a common basis for the development of guidelines in Physiotherapy. This framework aims to assist Member Organizations of the European Region of WCPT for several reasons:

- To assist Member Organizations who may be considering, or already involved in, the development of a clinical guideline.
- To set out the methodology for clinical guideline development as a standard for Guideline Development Groups (GDG), in the European Region of WCPT.
- To assist Member Organizations in their understanding of clinical guidelines and their development.

The Executive Committee has agreed to collect information in order to revise and update the Report on the Practice of Physiotherapy in the European Region of WCPT. The report should address four major items: Regulation of the Profession, Access to Physiotherapy Services, Autonomy of the Profession and Reimbursement Systems. The information collected will be available on the European Region website.

A questionnaire on Standards of Practice was approved by the Executive Committee in order to gather information from the Member organizations about the ongoing process to implement Core Standards.

Taking into consideration the 15th International Congress WCPT 2007, the European Region of WCPT has received proposals from 11 candidates for Member of the International Scientific Committee 2004-2007.

Seven of the candidates proposed by the Member Organisations, are physiotherapists with a relevant academic scientific curriculum and are clearly adequate for the job. Since it is necessary to select only 2-3 candidates, it was decided that special attention be paid to each candidates *"familiarity with WCPT's International Congresses"*.

Following this criteria, and according to what is explicit in their Curriculum Vitae, the Executive Committee of the European Region unanimously agreed to nominate two candidates as preferential ones. This decision was forwarded to the WCPT, who are expected to reach a final judgment on the Nominees applicants soon.

The nomination forms for the Working Groups for the period 2004-2006 were approved by the Executive Committee. Member Organisations will be invited to submit nominations for participation in the 3 Working Groups of the European Region. Each nomination must have the approval of their national Member Organisations since they will be responsible for fully supporting the nominee financially to attend meetings. The application form, enclosed with the Guidelines for Working Groups, will be sent to the Member Organisations in April with a reply deadline of 1stJune 2004. Candidates will be asked to prepare a Statement of intent and to enclose their Curriculum Vitae.
