	<ul> <li>A certified copy of the migrant's diploma and details of the curriculum of physiotherapy education undertaken, indicating: duration of study in academic years or description of the subjects studied, indicating the number of hours in each both theoretical and practical.</li> </ul>
	<ul> <li>Certificate issued by the competent authority in the country of origin, demonstrating that the applicant is a professional who meets the requirements of the Directive of the European Union to practice and is not disqualified for it.</li> </ul>
	<ul> <li>If a Member State which issued the title, the profession is not regulated, should submit a document certifying issued by the competent authority, have worked for 2 years full- time during the previous 10 years.</li> </ul>
